4. Planning - 18/P/3498/FUL - Retrospective application for a stable block on land adjacent to Ivy Cottage, Blagdon Lane, Butcombe

Councillors agreed that they would object to the application on the following grounds:

The applicant had not applied for planning on the current 2 bay stable and is already seeking an extension.

Location and scale will change the landscape.

Constitutes inappropriate development within the ANOB.

Being located in open rural countryside and not near an existing building cluster.

Located very close to the popular Blagdon lake site of special scientific interest (SSSI).

Potentially would represent further incremental development in a valuable and unspoilt area of protected north Somerset landscape.

# 6. Exchange of information

DW provided an update on his contact with Phil Bush from North Somerset Council regarding maintenance of highways in Butcombe.

Councillors discussed an application could be submitted to Bristol Airport's Diamond Fund for funding to help with highway repairs.

ACTION: DW to liaise with his contact at the Diamond Fund to establish if an application would be acceptable.

IM advised the VETS service is currently on hold whilst discussions with South West Ambulance service are continued as they currently will not support the VETS scheme. IM also advised that the phone currently fitted within the Defibrillator phone box is insufficient and does not allow you to call 999. IM has made enquires with BT for installing a 999 phone line. The cost of this would be £450.00. Without an active phone line, the phone within the phone box is defective.
